### **Museum of Art Courtyard**

6 p.m. – 12 a.m.

1 - 400 people.....\$7,500

For each additional 100 guests, a \$1,000 fee applies (up to 800 total guests)

Price includes:

Museum of Art Courtyard and Loggia

North or South Galleries to remain open for self-touring from 6 p.m. to 8 p.m.

For Wedding Events, additional items included are:

Use of the grounds for 2 hour photo shoot (prior to or day of wedding/reception)

1 hour wedding rehearsal

### **Ca' d'Zan and the Bay front**

6 p.m. – 11 p.m.

1 – 250 (maximum) people..... \$7,500

Price includes:

Ca' d'Zan front lawn area, Campiello, Bay Front and Terrace

1<sup>st</sup> floor of Ca' d'Zan to remain open for self touring from 6 p.m. to 8 p.m.

For Wedding Events, additional items included are:

Use of the grounds for 2 hour photo shoot (prior to or day of wedding/reception)

1 hour wedding rehearsal

### **Belvedere Tower at the Ca' d'Zan**

6:00 p.m. – 10:00 p.m.

1 – 8 (maximum) people.....\$5,000

Includes dinner/beverages for up to 8 guests

### **Circus Museum Backyard**

6:00 p.m. – 10:00 p.m.

1 – 150 (maximum) people.....\$2,500

Entire Museum is open for self-touring; food/beverages allowed in one interior area

### **Circus Museum's Tibbals Learning Center**

6:00 p.m. – 10:00 p.m.

1 – 80 (maximum) people.....\$1,500

Entire Learning Center remains open for self- touring;  
food/beverages allowed inside exterior tented area

## Contractual Payment Terms

- ❖ 50% of payment is due with original copy of signed and initialed rental contract two weeks after contract is issued. No exceptions are allowed.
- ❖ The remaining 50% balance is due 180 days prior to event.
- ❖ If event is booked within 180 days of the event date, then full payment is due upon signing and initialing the contract.
- ❖ There are no refunds.
- ❖ Event furniture and equipment must be rented from one of our approved vendors.
- ❖ Please note all locations have limited electrical capabilities.
- ❖ Damage deposit of \$500.00 is added to rental fees, and refunded after event if no policy infractions or damages are found.
- ❖ Fundraising, Political and Revenue Generating Events are prohibited.
- ❖ All fees are subject to change without notice.
- ❖ All rentals are subject to a 7% sales tax.
- ❖ 50% deposit due at contract signing forfeited upon cancellation at any time afterward.
- ❖ Any changes to contract will result in an addendum fee. To add a venue, a new contract will be issued. To change a date, one contract will be cancelled and a new contract will be issued.
- ❖ Total forfeiture of full rental fee occurs if User cancels for any reason less than 180 days prior to event.
